Youth Dreamers Foundation Scholarship Report



It is immense pleasure for me to submit the report of The Youth Dreamers Foundation. The Youth Dreamers Foundation under Pernod Record India Foundation (SIGRAM) has maintained its social commitment by providing scholarships worth Rs. 1 lakh to needy and aspiring students of Maratha Vidya Prasarak Samaj' Karmaveer Raosaheb Thorat Arts and Commerce College, Vani. Hon'ble Principal Dr. R.D.Darekar reminded the Youth Dreamers Foundation that the number of students are economically weaker section. Our Principal Dr. R. D. Darekar requested The Youth Dreamers Foundation. For the purpose of providing financial assistance to the students who are not receiving any scholarship from the government, it is necessary to contact the Scholarship Department from The Youth Dreamers Foundation under the Pernod Record India Foundation (SIGRAM) to provide scholarships to such needy students.

The Hon. Rajendra Deshmukh, Pernod Record India Foundation (SIGRAM) and Youth Dreamers Foundation Director Mr. Saurabh Malhotra, and CEO Mr. Manish Sharma sanctioned Rs. 1 lakh as a grant for the 10 students of the Vani College. The students expressed their feelings that this scholarship has helped the students for education in the difficult situation of the Covid 19 pandemic. It is notable that the Youth Dreamers Foundation Scholarship Department under Pernod Record India Foundation (SIGRAM) has sanctioned this scholarship to the students of KRT Vani College continuously for three years during the difficult situation of the COVID 19 pandemic. In the academic year 2019-20, 64 students have received economic assistance of Rs. 640000, each for Rs. 10 thousand. During the year 2020-21, a total of 39 students received per head Rs.10 thousand, the total amount is Rs. 390000. In 2021-22, 10 students have received financial assistance of Rs. 1,00,000. Per students get Rs. 10000.

To make this program a success, Seagram Company Manager Shri. Rajendra Deshmukh, Director of Youth Dreamers Foundation, Mr. Saurabh Malhotra, and CEO. Mr. Manish Sharma also provided time to time valuable guidance for us in the enhancement of students. Raman Tekale, Project Manager, 'Youth Dreamers Foundation', assisted in getting the scholarship. 'Youth Dreamers Foundation' is an organization whose parents accept the guardianship of students for their future.

Vani village is a purely tribal and hilly area, so the number of students in this area are staying away from higher education due to a lack of financial support. Though students are economically weak who have received financial support from Pernod Record India. It has helped in bringing students from rural areas into the mainstream. To make this scholarship programme a success, Shri. Rajendra Deshmukh, Seagram Companies Manager guided and cooperate with us very eagerly and heartily. Raman Tekale, Project Manager, Youth Dreamers Foundation, assisted in getting the scholarship for our students. We are sincerely thankful to 'Youth Dreamers Foundation' and its team.

Objective

The Scholarship supports young people for 9th to 12th standard, ITI, Diploma, Graduate and Post-Graduate study, and actively fosters lifelong learning, fellowship and build a sustainable career.

The Scholarship is renewed every year for higher studies of the qualified existing candidate/PRIF Scholar on qualifying the eligibility criteria.

What Is Included?

Pernod Ricard India Foundation (PRIF) Scholarship will cover the Actual School/Institutes/University tuition fees.

The scholarship is tenable only at Nashik, Maharashtra.

Academic Year

2020-2021.

Relaxations

- Students belonging to SC/ST/Minority categories shall get 10% relaxation in qualifying percentage criteria.
- Girls students will get 5% relaxation in qualifying percentage criteria.
- Differently abled students shall get 20% relaxation in the above qualifying percentage criteria.

Eligible Criteria

- Should be a resident of Dindori Block of Nashik district, Maharashtra.
- Student's family income must not exceed 2.5 Lakhs per annum from all sources.
- Should have qualifying percentage of 75% to apply scholarship for std 9th, 10th, 11th & 12th.
- Should have qualifying percentage of 70% to apply scholarship for ITI/Diploma/Polytechnic Courses.
- Should have qualifying percentage of 60% to apply scholarship for Graduation.
- Should have qualifying percentage of 60% to apply scholarship for Post-Graduation.

Application Process

- **Step 1:** Fill the form with all relevant and required documents and submit.
- **Step 2:** Document verification and validation. (Due to Covid-19, if your exam and result announcement for the current year has been delayed, we are considering a special relaxation).
- **Step 3:** House and address verification of the candidate selected in the second round.
- **Step 4:** Announcement of the Final Selected Candidate & Disbursement of Scholarship.

Selection

- Should qualify the eligible academic & socio- economic criteria.
- All the academic documents should be True.
- A selection committee from Pernod Ricard India Foundation (PRIF) will reviews applications and select the deserving candidate for the scholarship.

Selection Updates and Timelines

For the Academic year 2020-2021 PRIF Scholarship, student who has been selected will receive a call and his/her name will be updated on the school/college/institute notice board about your application status at each step of the selection process.
